Kelly Henry welcomed the group and reviewed the mission of the PLC.

#### **Plant Update**

- Rob Nixon gave an update on:
  - Owens Corning Plant Operations
    - The results were presented of the Formulation Trial and Stack Sampling, which took place in October. As a result of these results, the plant made plans to extend two general exhaust stacks.
    - Two furnace exhaust stacks were extended in early January.
- Brett Arnold provided:
  - A high level overview of the various projects implemented over the past few years and the progress achieved by the facility since 2016.
  - A review of the validated Source Testing Program scheduled to take place in April.
- Megan Moore gave an update on:
  - Health and Safety
    - Pre-task planning discussions occur every day before starting a task. The site achieved 1,226 discussions in 2019, exceeding the initial target of 365.
    - Employees are participating in Hazard Recognition and Control Training to build awareness for accident prevention.
  - Community
    - The Owens Corning team will be working on a new Habitat for Humanity project at City Place starting Feb. 13. PLC members are welcome to participate.

## **Air Monitoring Program**

- Mark Vanderlaan reviewed data results in the draft Ambient Monitoring Report for fourth quarter, 2019.
- He gave an update on the Annual Average of Ambient Air Monitoring. A formal review of the data will be presented at the April meeting.

## Regulatory Reporting

- Rob Nixon provided updates on:
  - ECA Renewal Application, which was submitted in October. The public comment period is open until February 7, 2020.
  - The Emission Summary and Dispersion Modelling Report.
  - Regulatory actions scheduled for 2020.

#### **Community Hot Topics**

- Diane Sudds said she is keeping Waterworks employees updated on Owens Corning's actions.
- Shakiba Shayani reviewed the programs being offered by the Chamber of Commerce, including a session on Smart Circular Economies and another on the Smart Cities Initiative.
- Beverley Hale said the University of Guelph is conducting a search for a new president. The current president's term is up in July.

- Nicole DeFrancesco thanked Owens Corning for sponsoring a trip for the school's 225 students to see a Christmas movie.
- Bo Cheyne reminded everyone that the flu season is upon us and recommended getting a flu shot. She mentioned that the public health authorities are watching the emerging coronavirus.
