# Plant Update

- Rob Nixon gave an update on:
  - Owens Corning Plant Operations
    - The Symposium held in 2017 -- and subsequent research -- has resulted in numerous actions to reduce emissions.
    - Formulation Trial and Stack Sampling confirms significant reductions.
- Brett Arnold gave an update on the Internal Air Flow Assessment conducted in December 2018. Studies are on-going.
- Megan Moore gave an update on:
  - Health and Safety
    - Safety Record -- The plant had no incidents to report.
    - Education -- Hazard Recognition and Control Specialist Training was held earlier this year.
    - Lighten Up Employees are again participating in a corporate-wide wellness program.
    - More Opportunities to Exercise -- Now that spring is here, the employees have started the Monday Lunch Walking Group.
  - Community
    - Tree Planting Program A tree planting is being organized for June 5 and 6 to mark World Environment Day. More than 150 trees and hundreds of herbaceous plugs will be planted in a large lot adjacent to the Owens Corning parking lot. The PLC members are invited to participate. Principal Nicole DeFrancesco, Sacred Heart School, said that her students would be excited to help.
    - Habitat for Humanity During "Build Day 2018," the Owens Corning team worked for two full days at Cityview Place to help construct and fireproof new housing. Five families occupy the new homes, with two more set to move in at the end of May. A new project is scheduled for September.
