Plant Update

- Rob Nixon gave an update on:
 - Owens Corning Plant Operations
 - The Symposium held in 2017 -- and subsequent research -- has resulted in numerous actions to reduce emissions.
 - Formulation Trial and Stack Sampling to date confirms significant reductions.
 - Another round of stack sampling is scheduled for October, which should reflect more recent improvements (reflected in presentation by Brett Arnold and summarized below).
- Brett Arnold gave an update on:
 - Internal Air Flow Assessment conducted in December 2018. Studies are on-going.
 - As part of this effort, the company is replacing two general ventilation fans in the furnace area.
- Megan Moore gave an update on:
 - Health and Safety
 - Safety Record --The plant had no incidents to report.
 - Noise Issue On July 9, the company received a call from a neighbour regarding a noise coming from the plant. The facility team looked into what was causing the sound and took measures to correct it.
 - Heat Stress With the summer in full swing, it is important to stay safe and hydrated during extremely hot weather.
 - o Community
 - Tree Planting Program A tree planting took place June 5 and 6 to mark World Environment Day. More than 150 trees and herbaceous plugs were planted in a large lot adjacent to the Owens Corning parking lot. Students of Sacred Heart School and a member of the PLC participated in the highly-successful event.
 - Habitat for Humanity The Owens Corning team will be working on a new project in September.

• Craig Vallesi updated the group on Chamber of Commerce activities, including Membership Appreciation Night on Aug. 19, the Annual Golf Tournament on Sept. 6 and a Business Expo with conjunction with the Kitchener-Waterloo and Cambridge Chambers of Commerce during the second week of October.

- Nicole DeFrancesco reported on recent programs held at Sacred Heart School, including the first annual golf tournament at the end of May and the annual Carnival on June 8. School enrollment is holding steady, with a third kindergarten class being added, starting in September.
- Diane Sudds updated the group on construction projects and improvements being made at the Waterworks facility.
- Shawn Zentner reported on an initiative by the Health Department to conduct a threeyear assessment on the effects of climate change. This is being done in an effort to better understand potential public health risks.
- Beverley Hale said the University of Guelph is opening a new state-of-the-art \$18 million agricultural research facility for the study of cattle, specifically beef herds. Construction is underway on additional research facilities which will focus on swine and pork production.
